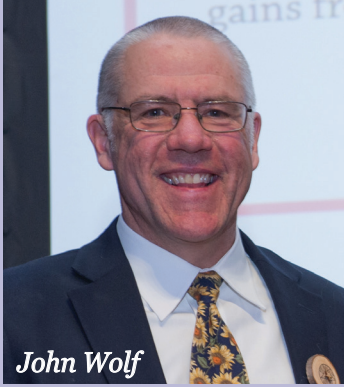


OUR MISSION

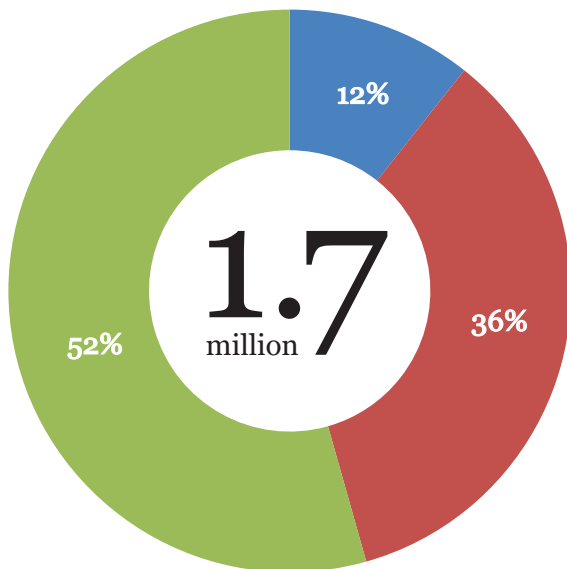

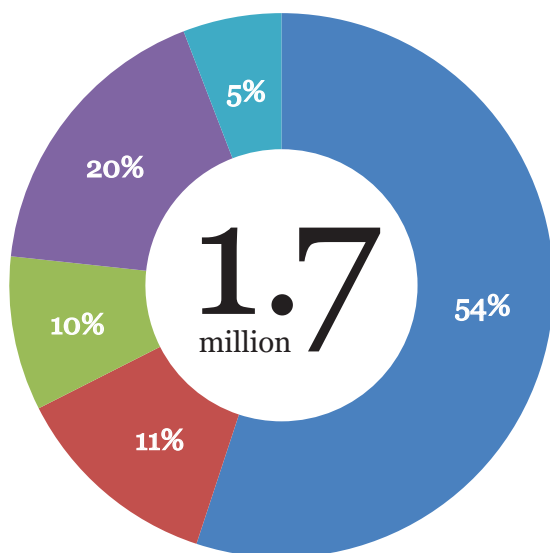

Student Support Services Remain Intact Despite Move to Virtual Learning



Guidance, Counseling, and Adult Mentoring

In addition to the academic support the boys received from their teachers during remote learning, they also benefited from the continuation of key aspects of the San Miguel student support experience including Guidance Class, Individual Counseling, and online connections with their adult mentors.

What is Guidance Class?

Taught by Dean of Students Taysha Paulo, Guidance Class is a time each week when a full grade will meet with her to talk about anything from life at home to personal challenges to their dreams of going to the NBA. The boys appreciate this opportunity to step away from the academic expectations of school and talk about growing up. Many students end up developing an important and lasting relationship with Taysha, and years later credit her and that class for the man they have become.

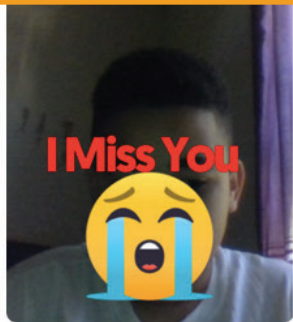

How Does Counseling Work?

San Miguel is blessed to have two fantastic mental health counselors on staff. These two professionals meet regularly with students who have asked for support as well as with students we have identified as needing one-on-one counseling. Counseling sessions are confidential and address issues ranging from academic stress to challenges at home. When we transitioned to remote learning last spring, our counselors did not miss a beat, continuing their sessions with students virtually. The stress created by this pandemic and the impact of isolation on the boys cannot be overestimated, so being able to connect, albeit virtually, with a counselor with whom the student already had a trusted relationship, was critical.

What the Heck is Flipgrid?

Our adult mentor program is another important layer of support for the boys of San Miguel. When we are in school, adult mentors commit to coming to school weekly to have lunch, play board games and talk with their mentee. For many students, their mentor visits are the highlight of their week. So, when we went virtual, the boys no longer had that critical touchstone. They, and their mentors, expressed a deep desire to find a way to stay connected. Dean of Students Taysha Paulo tapped into an online app called Flipgrid which enabled students to make videos and post them to a shared digital board where they could be seen by students and mentors. While a virtual connection could not replace an in person meeting, students and mentors alike appreciated the opportunity to see each other's faces, check in on each other's families and give one another support and encouragement.



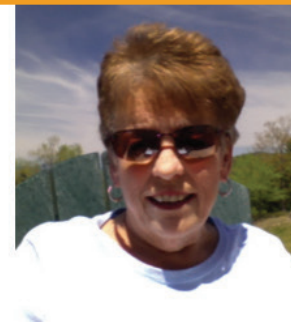
